## Tender Notice

For the provision of 15000 ton Maize Crop for silage

Punjab Livestock & Dairy Development Board (PLDDB) is a non-profit Organization established under Section 42 of the Companies Ordinance, 1984. PLDDB invites sealed separately Technical & Financial Bids from interested NTN registered parties/ growers for the provision of estimated 15000 Ton Silage Maize Crop (10 thousand ton from supplier & 5 thousand ton from direct farmers) for the purpose of Silage making at all stations including Kamal Chishti Chowk, Kasur, Faisalabad road, Chaniot and Hujra Bai Pass, Dipalpur on the framework contract basis. PLDDB may shortlist the different parties for different stations keeping in view the price fluctuation.

As per the mandate of PLDDB to strengthen the small farmers and to minimize the middle-man role in the marketing of agricultural products, PLDDB encourages the farmers to participate directly in the Tender to avail the maximum margin of the goods. Firms are required to submit the financial quotations of chopped material reach at mentioned stations whereas farmers are required to submit the quotations of un-chopped material reach at mentioned stations. Financial evaluations of both, Firms and Farmers will be made separately and on the price quoted by the farmers, PLDDB will determine a lowest per kg crop price on the farmers end and will purchase the crop on the same price across the season by interested farmers.

Interested parties and farmers may send sealed envelopes of Technical (only firms) & Financial Bids separately sealed. Firms (not farmers) are required to submit 1% of estimated Financial Bid (estimated financial bid is Rs. 12,500,000 for each site) as bid security (refundable) at the under given address on or before 10<sup>th</sup> April, 2017 till 12:00 pm. Tender will be opened at 12:30 pm on the same day in the presence of all Bidders or their authorized representatives. Firms are also required to submit 2% of total contract amount as performance security guarantee which will be returned after the completion of contract period.

Tender Document is immediately available at PPRA MIS and PLDDB official website and the same may be obtained from Procurement Section of PLDDB Head Office, immediately. However the bidders are required to submit PKR 1000 (non-refundable) to the Account Department of the company before the submission of Tender. PLDDB reserves the rights to accept or reject all the tenders prior to acceptance, as per PPRA rules 2014.

**Terms & Conditions:**

- a- At least 05 years experienced company/ maize grower in the same field may participate in the Bid.
- b- PLDDB needs maize crop at 3 mentioned stations as per its requirement under framework contract.
- c- As per plan PLDDB will procure 10 thousand ton chopped maize crop from supplier/ Firm & 5 thousand ton unchopped maize crop from direct farmers on 3 sites including Kamal Chishti Chowk Kasur, Faisalabad road Chaniot and Hujra Bai Pass Dipalpur.
- d- PLDDB required two kinds of crop, stationed maize crop from farmers and stationed chopped maize crop from Firms.
- e- Tenders received after due date and time will not be entertained at any cost.
- f- PLDDB encourages the legal business in the country so only NTN registered Firms may participate in the Bidding process.
- g- Bidders are required to submit 1% (refundable) of Financial Bid as earnest money along with Bid submission.
- h- Successful Bidder will deliver the product at defined stations and company will not bear any freight charges or other expenses like vehicle fuels, maintenance or toll taxes etc.
- i- Successful Bidder is required to provide the maize crop as per requirement of PLDDB. In case of failure, the contract will be considered breached and performance security amount will be forbidden.

- j- Successful Bidder is required to provide the Maize when the PLDDB will demand, In case of failure, the contract will be considered breached and performance security amount will be not be returned.
- k- Financial invoices should be inclusive all kinds of taxes (if any), PLDDB will not bear any tax.
- l- Quantity of maize crop may increase or decrease as per need of PLDDB under framework contract umbrella.

1. Any offer not received as per Terms and Condition for the tender enquiry is liable to be ignored.  
No offer should be considered if,

  - II. Received after the time and date fixed.

3. Successful bidder will provide services within 30 days of the agreement.
4. The procuring Agency reserves the right to purchase full or part of the store /service or ignore/scrape/cancel the tender assigning any reasons (as per PPRA Rules 2014 clause No. 35).
5. (a) In the case the offer is withdrawn, amended or revised during the validity period of the order, the earnest money is liable to be forfeited.  
(b) In the case of contractor fails to execute the contract strictly in accordance with terms and conditions laid down in the contract at risk and expense.
6. The Procuring Agency reserves the right to claim compensation for the loss caused by in the delivery of store and provision of services, as per detail.

2. Tender should be quoted final rates both in word as well as in figures.
3. Bidders are required to submit 2% of financial bid as earnest money (refundable in case of non-successful bidding) in favor of PLDDB.
4. Any condition, ambiguous or called incomplete offer in any respect shall be ignored. No supplementary or revised offer after the opening of tender shall be entertained.
5. The tenders should indicate the tender's complete address or the place where store / service will be offered for inspection.
6. The tender shall enclose catalogue/leaflets/literature and other technical data, if any in respect of store/service offered by them.
7. The tender should specifically indicate their Sales Tax No.
8. Any erasing / cutting / crossing etc appearing in the offer must be properly signed by the person signing in the tender. Moreover, all pages to the tender must also be properly signed. Offer with any over-writing shall in no circumstances be accepted.
