- B. Procuring agency requires accumulative rate against above said two items.
- C. At least 02 years experienced company in the same field may participate in the Bid.

- E. PLDDB encourages the legal business in the country so only NTN & GST registered Firms may participate in the Bidding process.

- H. Successful Bidder will deliver the products at the specified points of Chiniot within 35 days of job order.

2. Offer will remain valid for 90 days from the date of opening the tender.
3. Successful bidder will provide services within 30 days of the agreement.

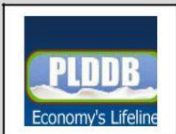
