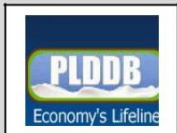

Corrigendum/Tender Notice **For Hiring of Security Agency Services**

Punjab Livestock & Dairy Development Board (PLDDB) is a non-profit Organization established under Section 42 of the Companies Ordinance, 1984. PLDDB intends to hire the services of a professional and legally registered (as per the law of the Government) Security Firms equipped with latest electronic security systems.

TERMS AND CONDITIONS:

1. The detailed bidding documents can be purchased on submission of request on company letter head along with Rs. 1,000/- (non-refundable) from PLDDB office during working hours (09:00 am to 05:00 pm) immediately after the publication of tender notice and the same may also be obtained from Procurement Section of PLDDB Head Office.
2. The services will be hired according to PPRA Single stage – two envelop procedure.
3. The Bid Security / Earnest Money @2 % Rs. 90,000/- of estimated cost (Rs. 4,500,000) in the form of “CDR i.e. Bank Draft, Pay Order etc.” in favor of “Punjab Livestock & Dairy Development Board” is required to be submitted with the Technical Bid.
4. The bids shall be submitted on or before 10:00 AM on **March 11, 2019** and that shall be opened on 10:30 AM on the same day in the presence of all Bidders or their authorized representatives.
5. The bidder shall not bid below the minimum rates of wages for security services fixed by the provincial government including all the applicable federal, provincial taxes etc.
6. PLDDB reserves the right to accept or reject all offers as per PPRA rules.

PLDDB Requirements regarding security services:

Punjab Livestock & Dairy Development Board is managing a 1600 acres Livestock farm named Livestock Experiment Station (LES) situated at Khizerabad, district Sargodha where multiple crops for experiment purpose are being cultivated and about 1200 pure Sahiwal breed cows and likewise pure Kajli breed sheep are being reared by farm management for research purpose. Khizerabad is a remote area having about 30 kilometers distance from Sargodha City. Following are the security requirements of PLDDB.

PLDDB requires the services of 22 guards equipped with latest weapons to secure the premises mentioned bellow. (Number of guards may increase or decrease as per PLDDB need)

Regarding security point of view, Head Office, Silage Project, Milk Project & LES Farm may be categorized into following sections:

1. Head Office, Lahore
2. Silage Sale (05) points (Chiniot, Kasur, Pakpatan, Hujra Shah Muqem)
3. Livestock Section of Farm
4. Agriculture Section of Farm
5. Genetic Improvement Section of Farm
6. Residential area of Farm
7. Milk Project Lab

PLDDB needs 24 hours foolproof security of:

- a) Livestock farm including Sheep, Cow, Dairy, Feedlot-Fattening and other sections of Livestock & Agriculture.
- b) Genetic Improvement Center.
- c) All sort of crops cultivated on estimated 1500 acres.
- d) Security of fodder cultivated in the different areas of farm especially to eliminate the green fodder theft by the locals.
- e) Security of the staff residence colony.
- f) Control the internal incoming and outgoing of goods at farm.
- g) Installation of latest electronic security systems.
- h) Development and implementation of security SOPs and Protocols.
- i) Eradicate all sort of external involvements (including social, political, pressure groups etc.) in the operational matters of farm.
- j) Eradicate the entrance of local people and their animals in the farm premises.
- k) Protection of the employees of the LES.
- l) Full security of Silage sale sites, silage bales, machinery, building, equipment's and employees.
- m) Full security of Head Office premises, all type of equipment's and employees.

Technical & Financial Bids' Submission instructions:

The Bids will be evaluated as per following criteria:-

1. Only APSAA and at least 02 years experienced registered Security Agencies are eligible to participate in the Bidding Process.
2. Initially contract will be made for one year which will be extended on the basis of performance of security agency.
3. Any offer not received as per Terms and Condition for the tender enquiry is liable to be ignored. No offer should be considers if,
 - I. Received without earnest money from unregistered firm or a firm not registered for the item / service mentioned in this tender.
 - II. Received after the time and date fixed.
 - III. The tender is unsigned.
 - V. The offer is conditional.
 - VI. The offer is from a firm blacklisted, suspended, or removed from the approved list.
 - VII. The offer is recovered from the telegram.
 - VIII. Offer received from shorter validity than required in the tender enquiry and
 - IX. The offer is for store/ service NOC conforming to specification Indicated in the tender enquiry.
4. Offer will remain valid for 30 days from the date of opening the tender.
5. Successful will provide services within 10 days of the agreement.
6. A single package containing technical and financial separate bids, duly completed, signed, stamped and sealed with the tender document will be submitted in the name of Senior Manager Farm.
7. The procuring Agency reserves the right to purchase full or part of the store /service or ignore/scrape/cancel the tender assigning any reasons (as per PPRA Rules 2014 clause No. 35).
8. (a)In the case the offer is withdrawn, amended or revised during the validity period of the order, the earnest money is liable to be forfeited.
(b) In the case of contractor fails to execute the contract strictly in accordance with terms and conditions laid down in the contract at risk and expense.
9. The Procuring Agency reserves the right to claim compensation for the loss caused by in the delivery of store and provision of services, as per detail.

GENERAL INSTRUCTIONS

1. Tender should be addressed to the Senior Manager Finance & Admin.
2. Tender should be quoted final rates both in word as well as in figures inclusive all sorts of taxes.
3. Bidders are required to submit 2% earnest money (refundable in case of non-successful bidding) of financial bid in favor of PLDDB.
4. Any condition, ambiguous or called incomplete offer in any respect shall be ignored. No supplementary or revised offer after the opening of tender shall be entertained.
5. The tenders should indicate the tender's complete address or the place where store / service will be offered for inspection.
6. The tender shall enclose catalogue/leaflets/literature and other technical data, if any in respect of store/service offered by them.
7. The tender should specifically indicate their G.S.T. No. and Sales Tax No.
8. Any erasing / cutting / crossing etc appearing in the offer must be properly signed by the person signing in the tender. Moreover, all pages to the tender must also be properly signed. Offer with any over-writing shall in no circumstances be acceptance.
9. Certificate should be given by the tender that they will be responsible for the replacement of services if the same is found to be stander and or avalanche with the specification given in the tender enquiry. In the case SIMILAR service offered variance with the specification superior to the one specified in the tender enquiry shall however, be acceptable.
10. In case of representative's participation in the bidding process, he/ she must have NOC by the senior management of his/her office.

Short-listing Criteria

All prospective bidders are hereby informed that following criteria will be considered for short listing the Bidders. Consequently, only technically short listed bidders will be considered for next stage.

Short listing of bidders will be done on the basis of score obtained out of 100 according to the following table:

NOTE: In order to qualify for the financial Bid, bidders are required to obtain a minimum score seventy five (75) out of hundred (100).
