Terms & Conditions:

- a) Parties are required to submit the financial quotation on the basis of mentioned bale size inclusive all kind of taxes.
- b) At least 02 years experienced company in the same field may participate in the Bid.
- c) Tenders received after due date and time will not be entertained at any cost.
- d) PLDDB encourages the legal business in the country so only NTN registered Firms may participate in the Bidding process.
- e) Bidders are required to submit 2 % (refundable) of Financial Bid as earnest money along with Bid submission.
- f) Successful Bidder will deliver the product at production sites of silage and company will not bear any freight charges or other expenses like vehicle fuels, maintenance or toll taxes etc.
