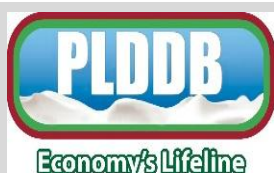

- 4) The bidders shall submit the **bids through EPADS** up to **10:30 am** on **June 17, 2025** and that shall be opened on **11:00 am** on the same day.
- 5) PLDDB reserves the rights to accept or reject all the tenders prior to acceptance, as per PPRA rules 2014.
