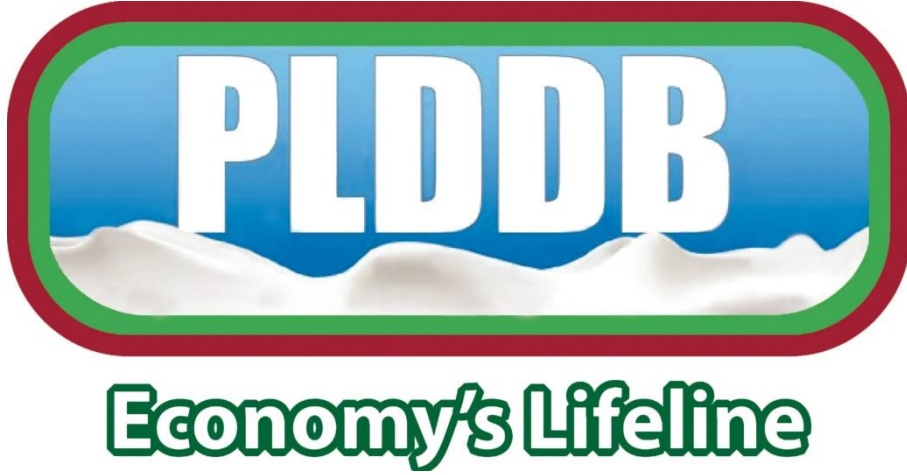

Auction Notice

Vehicles, Tractors & Motor Cycles at LES-Farm

Punjab Livestock & Dairy Development Board (PLDDB) intends to conduct an open auction, in accordance with the applicable Punjab Government rules and procedures, for the disposal of its vehicles, motorcycles, and tractors on an "as is, where is" basis. Interested parties may visit and inspect the aforesaid vehicles, motorcycles, and tractors at the premises of the Livestock Experimental Station (LES), 60 Chak Shumali, Khizerabad, District Sargodha, either in person or through their duly authorized representative(s), between 9:00 AM and 5:00 PM, on any working day prior to the date of auction, i.e., 21st January 2026.

The visitors shall be required to present valid business registration documents/authorization and, in the case of individual bidders, a valid CNIC. Furthermore, all prospective bidders must possess an active tax status with the Federal Board of Revenue (FBR).

Brief Auction Terms:

- All applicable government taxes, including auction tax at the prevailing rates, shall be borne entirely by the successful bidder(s) and shall be added to the respective winning bid amount(s).
- The date for the open auction of said Vehicles, Motorcycles & Tractors at above mentioned premises will be held on **21st January 2026**, at 03:00 PM, purely on "as is where is basis".
- The auction will be held in the presence of all the prospective bidders.
- PLDDB exclusively reserves its right either to accept or reject all or any of the bid(s) while observing Punjab Government rules.
- The auction will be conducted on a "lot wise" basis against each vehicle.
- All other terms and conditions will be available on PLDDB's website, which shall be treated as an integral part of this Auction Notice.
- All prospective bidders must deposit a sum of PKR 30,000/ (Refundable) and PKR 3,000/- (Non-Refundable) as security deposit amount and registration fee for participation in the bidding process for vehicles and tractors with the exception of bikes, in the form of a Bank Draft/ Cash Deposit Receipt (CDR), or cash, payable in favour of "Punjab Livestock & Dairy Development Board."

Introduction

Punjab Livestock & Dairy Development Board (PLDDB) is a non-profit Organization established under Section 42 of the Companies Ordinance, 1984. The PLDDB has been aimed to develop Livestock & Dairy sector of the Punjab while facilitating small & large farmers in production, processing & marketing with the latest infrastructure and modern farming technologies to improve their animals' genetics and milk/ meat production ratio. PLDDB is also meant to accelerate private investment opportunities in this sector. The whole domain will result-in poverty alleviation and economic growth of the Punjab. PLDDB has focused on the up gradation of more than 90% small farmers of the province by providing technical & in-kind assistance as per their need.

II. Scope of Auction

The auction of vehicles, tractors & motor cycles at LES-Farm Khizerabad Sargodha should be in accordance with the auction terms and conditions.

III. Important Note

All participants complying with criteria given in the auction documents are eligible for this bid. Prospective bidders must ensure submission of all the required documents indicated in this auction documents. Bids received without required documents mentioned in the auction document will be rejected.

IV. Auction Terms and Conditions

FOR PUBLIC/OPEN AUCTION OF VEHICLES, TRACTORS AND MOTOR CYCLES OWNED BY PLDDB.

1. An affidavit(s) on legal stamp paper (original) shall be furnished by the prospective bidder(s) that he/she/they and/or his/her/their entity is/are not blacklisted by any government/semi government department(s).
2. The Highest Bidder(s) will be declared a Successful Bidder(s) after due process of verification, formalities, procedure and the law applicable thereto.
3. If the highest bid is lower than the reserve price mentioned in the document, PLDDB reserves its right either to accept or reject the highest bid without assigning any reason.
4. PLDDB shall hand over the Vehicles, Tractors & Motorcycles to the Successful Bidder(s) respectively, without any further R&M and on the terms and conditions as set out in the Auction Notice, this Indenture and on the terms as settled during the time of the bidding process.
5. In case any asset(s) and/or Property of PLDDB is damaged during the shifting of Vehicles, Tractors & Motorcycles by the Successful Bidder(s), the Successful Bidder(s) shall be liable to make good the loss as per the satisfaction of PLDDB.
6. Vehicles, Tractors & Motorcycles shall be auctioned one by one.
7. All prospective bidders must deposit a sum of PKR 30,000/ (Refundable) and PKR 3,000/- (Non-Refundable) as security deposit amount and registration fee for participation in the bidding process for vehicles and tractors with the exception of bikes, in the form of a Bank Draft/ Cash Deposit Receipt (CDR), or cash, payable in favour of "Punjab Livestock & Dairy Development Board.
8. The Successful bidder(s) shall have to deposit Twenty-Five (25%) of the highest bid(s) amount at the spot, failing which, the bid(s) shall automatically stands rejected, and the token money deposited by Successful bidder(s) shall be forfeited and thereafter, such vehicles shall be allocated to Second Highest Bidder(s), likewise, in case of failure of the Second Highest Bidder to deposit the Twenty-Five (25%) bid amount, the same principal as narrated above would be opted, and the third Highest Bidder would be declared the successful Bidder, if his/her/its Bid amount is above the Reserve Price and PLDDB would consider its/his/her bid a reasonable.
9. The Successful Bidder(s) shall be bound to deposit the balance Bid amount(s) within three (03) working days after the issuance of an acceptance letter(s) by PLDDB. In case of failure to deposit the balance Bid amount(s) within the aforesaid stipulated period of time, the amount(s) so deposited by the Successful Bidder(s) shall stand forfeited.

10. The payment of all government taxes, whether Federal or Provincial, duties and levies etc. applicable thereto, shall be the sole responsibility of the Successful Bidder(s).
11. The security deposited amount will be returned to the Unsuccessful Bidder(s) after due completion of Auction process and/or its logical conclusion.
12. PLDDB at its sole discretion may reject all or any of the Bid(s) at the time of auction and/or at any stage of auction, without intimation.
13. The Successful Bidder(s) shall be responsible to take the delivery of the Vehicles, Tractors and Motorcycles within seven (07) clear days from the date of issuance of the acceptance letters.
14. Lifting of Vehicles, Tractors and Motorcycles shall not be permitted during night hours or during public holidays otherwise the permission issued shall be canceled and the same shall be re-auctioned without any notice.
15. If the Successful Bidder(s) wishes to leave/abandon the Bid(s) before issuance of the Acceptance Letter(s) by PLDDB, then the entire amount paid in advance including the Bid(s) security amount(s) etc., in such eventuality, PLDDB shall not be liable to refund and/or return any payment to such Bidder(s) so deposited by him/her/them with PLDDB in connection to the Auction under reference.
16. The successful bidder shall not damage the surrounding, greenery or structure of the building in any manner what so ever.
17. The Successful Bidder(s) shall not sublet the awarded Bid(s) as a whole or in part to any other party or organization etc.
18. In case of any complaint or dispute between PLDDB and the Successful Bidder(s), the matter shall be referred to the Chief Executive Officer (CEO) of PLDDB whose decision shall be final and binding upon the Parties. The decision of the CEO shall not be challenged by either Party in any forum of law.
19. Those who wish to participate in the bid may submit their respective applications along with the necessary documents and security deposit amount etc. as per the conditions of the Auction Notice to the office of the undersigned even on the same day of bidding before start of the auction.
20. PLDDB may terminate the bidding process at any time without assigning any reason.
21. Open auction will be conducted on "as is, where is" basis against each vehicle, tractor and motor cycle separately.
22. Auction Notice shall be considered as an integral part of this instrument.

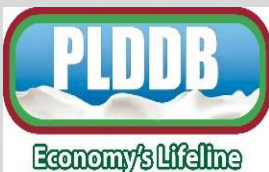
